

## BUSINESS WOMAN OF THE YEAR NOMINATION FORM

### CRITERIA

**Leadership:** a leader who has earned great respect from peers, staff, competitors and community. A skilled individual at taking calculated risks that materialises into sustainable success.

**Term:** The candidate must have been in the current position of leadership for a minimum of 3 years.

**Footprint:** The candidate must be a leader from an African based company and an African footprint beyond their region is favourable.

**Financial Acumen:** Under the candidates' leadership, the finances should indicate profitability and a growth rate indicating long-term sustainability. Achieved significant business milestones (e.g., merger, acquisition, license, major funding, revenue)

**Turnover: To be discussed- (relative to size of company) (corporate vs Private)**

**Corporate Social Responsibility:** Evidence must be provided of mentoring through the transfer of skills and a high involvement in projects aimed at **empowering other African females**. The candidate must share the values practised within the enterprise and the community and participation in positive social impact programmes.

**Corporate Governance:** How does your business demonstrate commitment to its people and wider stakeholders?

**Role Model:** Nominees must be considered role models within their employers' business, Business or their community and in this regard, with special focus on transformation and mentorship inspired others striving for success

**Documentation:** This nomination form must be **signed** and accompanied by the following:

- A detailed CV/Biography
- High resolution "head and shoulders" picture of the nominee
- Certificates of achievement
- Previous awards
- Newspaper articles
- Company clip/video link or company profile
- Latest tax clearance certificates
- Audited financial statements for the company (past 3 years)
