The candidate must have displayed depth of entrepreneurship or business leadership, exceptional quality of innovation, collaboration and co-creation of product/services making significant impact on the Continent of Africa.

CRITERIA

Leadership: A leader who through their industry successes; have created significant social responsibility that reflects on building Africa as a continent. A leader who has earned great respect from peers, staff, competitors and community. A skilled individual at taking calculated risks that materialises into sustainable success.

Term: The candidate must have been in the current position of leadership for a minimum of 3 years.

Footprint: The candidate must be a leader from an African based company and an African footprint beyond their region is favourable.

Financial Acumen: The candidate will have achieved positive financial results, increased shareholder value, sound management, proven corporate governance, together with intangible qualities such as integrity and vision.

Turnover: 50 000 USD

Corporate Social Responsibility: The nominee must have Individuals or team in an industry, creating value that impacts on the local or national community in relation to the promotion of the same peace, industrialization, and well-being of Africans. Evidence must be provided of mentoring through the transfer of skills and a high involvement in projects aimed at empowering others. The candidate must share the values practised within the enterprise and the community and participation in positive social impact programmes.

Corporate Governance: How does your business demonstrate commitment to its people and wider stakeholders?

Role Model: Nominees must be considered role models within their employers' business, Business or their community and in this regard, with special focus on transformation and mentorship inspired others striving for success.

TERMS & CONDITIONS 1. DEFINITIONS

- a. ABN means Africa Business News (Proprietary) Limited, registered under the applicable company laws of South Africa with registration number: 2008/002769/07, whose offices are located at Ground Floor, 155 West Street, Sandton, 2196, Johannesburg, South Africa.
- b. 'Categories' means the category of awards to be given described in detail in Clause 2 below.
- c. 'Entry', 'Entries' or 'Entrant' means a person, entity entering to compete in the AABLA, through submitting his/her complete entry form for any of the Categories for the Finale Event.

a. Acceptance of Terms

f. Assessment by Judging Panel
