Reach: Please indicate the scale of the innovation including who has or will benefit.

Footprint: The candidate must be a leader from an African based company and an African footprint beyond their region is favourable.

Prospectus: There must be evidence of a rigid long-term prospectus of the business (Sold Business Plan). They should be able to indicate their capability in attracting resources and growth in financial performance. Market details evident should include: market penetration, potential/proven impact on the market and positive influence in the marketplace.

TERMS & CONDITIONS 1. DEFINITIONS

a. ABN means Africa Business News (Proprietary) Limited, registered under the applicable company laws of South Africa with registration number: 2008/002769/07, whose offices are located at Ground Floor, 155 West Street, Sandton, 2196, Johannesburg, South Africa.

b. 'Categories' means the category of awards to be given described in detail in Clause 2 below.

c. 'Entry', 'Entries' or 'Entrant' means a person, entity entering to compete in the AABLA, through submitting his/her complete entry form for any of the Categories for the Finale Event.

d. 'Entry Period' means the period for accepting Entries commencing on 27 March 2023 and closing on 23 April 2023.

e. 'Event' and 'AABLA' means the All African Business Leaders Awards including, without limitation, the Finale Event, in respect of which ABN has the right to issuelnvitation.

a. Acceptance of Terms

ii. The Research Panel shall keep all documentation and information received and discovered by it during research ('Research Information') confidential and shall disclose the same solely to the Judging Panel for assessment.

iii. The Entrant shall not contact the Research Panel in his/her individual capacity or through their entity or otherwise, in any manner whatsoever with respect to the AABLA. Any such action by the Entrant shall make the Entrant eligible for immediate disqualification from AABLA.

f. Assessment by Judging Panel

i. The Judging Panel shall assess the Entrant based on the Research Information provided by the Research Panel and the Required Information and Supporting Documentation provided by the Entrant.

ii. The Judging Panel shall shortlist from the Entries- Nominees for all 13 (thirteen) Categories of the AABLA Finalists for the Finale Event and the Winners of the Finale Event of AABLA, based on objective criteria and in an impartial manner.

iii. The Entrant shall not contact the Judging Panel in his/her individual capacity or through their entity or otherwise, in any manner whatsoever with respect to the AABLA. Any such action by the Entrant shall make the Entrant eligible for immediate disqualification from AABLA.

g. Entrant's Consent to Research & Judging Process
