## MONETARY POLICY LEADERSHIP AWARD

The Monetary Policy Leadership Award recognises an outstanding central bank governor, monetary authority head, or equivalent policymaker who has demonstrated exceptional leadership, foresight, and effectiveness in shaping and implementing monetary policy. The recipient will have played a pivotal role in maintaining macroeconomic stability, managing inflation, supporting sustainable economic growth, and strengthening financial systems within their jurisdiction.

### CRITERIA

**Leadership:** A respected and credible policymaker who has earned the confidence of markets, government, financial institutions, and the public. Demonstrates sound judgement, independence, and the ability to navigate complex and often volatile economic environments.

**Policy Effectiveness:** Evidence of implementing monetary policy decisions that have successfully addressed key economic challenges such as inflation control, currency stability, interest rate management, and economic resilience. Clear demonstration of measurable impact over time.

**Term:** The candidate must have served in a senior monetary policy leadership role (e.g., central bank governor, deputy governor, or equivalent) for a minimum of three (3) years.

**Economic Impact:** Demonstrated contribution to macroeconomic stability and growth within their country or region. This includes maintaining price stability, supporting employment objectives where applicable, and fostering investor confidence.

**Innovation in Policy:** Introduction or effective use of innovative policy tools, frameworks, or approaches—particularly in response to emerging challenges such as global economic shocks, digital currencies, financial inclusion, or evolving financial systems.

**African Relevance / Footprint:** The candidate must serve within an African monetary authority or institution and demonstrate influence that extends beyond national borders—contributing to regional integration, cross-border financial stability, or pan-African economic collaboration.

**Financial System Stewardship:** Evidence of strengthening financial system stability, including regulatory oversight, banking sector resilience, and crisis management where applicable.

**Transparency & Communication:** Demonstrates clear, consistent, and credible communication of policy decisions to markets and the public, enhancing trust and reducing uncertainty.

**Governance & Independence:** Upholds the highest standards of institutional governance, professionalism, and independence in decision-making, free from undue political or external pressures.

**Role Model:** Recognised as a thought leader and role model within the policy and financial community, contributing to knowledge-sharing, mentoring, and the advancement of economic leadership across Africa.

## TERMS & CONDITIONS

### 1. DEFINITIONS

- a. ABN means Africa Business News (Proprietary) Limited, registered under the applicable company laws of South Africa with registration number: 2008/002769/07, whose offices are located at Ground Floor, 155 West Street, Sandton, 2196, Johannesburg, South Africa.
- b. 'Categories' means the category of awards to be given described in detail in Clause 2 below.
- c. 'Entry', 'Entries' or 'Entrant' means a person, entity entering to compete in the AABLA, through submitting his/her complete entry form for any of the Categories for the Finale Event.
- d. 'Entry Period' means the period for accepting Entries commencing on 27 March 2023 and closing on 23 April 2023.
- e. 'Event' and 'AABLA' means the All African Business Leaders Awards including, without limitation, the Finale Event, in respect of which ABN has the right to issue an invitation.

### 3. RULES FOR ENTRIES

- a. Acceptance of Terms
- i. All Entries are subject to these Terms and Conditions. These Terms and Conditions should be read carefully prior to submitting an Entry, any queries relating to them should be raised with ABN prior to such Entry being submitted, submission of an Entry will be deemed in acceptance of these Terms and Conditions.

- b. Entry Period

- c. Categories
- i. A person or entity may submit their Entry/Entries for all 13 (thirteen) Categories.
  - ii. The Judging Panel reserves the rights to limit the number of submissions made by a single Entrant or the Categories.
- d. Submission of Supporting Documents
- i. Incomplete submissions shall not be considered by the Judging Panel. It is the Entrant's responsibility to ensure that all forms are duly complete and all Required Information (as defined below) is provided with the submissions.
  - ii. Each Entry must be accompanied by all required information and documentation, including audited financial statements for the past 3 (three) financial year, description on current profiles, detailed write up on the business and complete up to date Curriculum Vitae ('Required Information').
  - iii. All Required Information submitted by the Entrant shall be considered confidential. ABN, the Research Panel and the Judging Panel undertake to not disclose the Required Information or any part thereof submitted by the Entrant, unless required to do so by legislation, law or a governmental authority, and with the written approval from the Entrant, which shall not be unreasonably withheld.

  - v. If discovered otherwise, by the Research Panel, Judging Panel or ABN- the Entrant understands that he/she will be disqualified from participation at AABLA, with immediate effect.

e. Evaluation by Research Panel

i. Upon submission of a complete Entry with the requisite Required Information and Supporting Documentation- the Research Panel will conduct detailed research on the Entrant including a reference check and document verification. The Entrant hereby consents and has no objection to the same.

ii. The Research Panel shall keep all documentation and information received and discovered by it during research ('Research Information') confidential and shall disclose the same solely to the Judging Panel for assessment.

iii. The Entrant shall not contact the Research Panel in his/her individual capacity or through their entity or otherwise, in any manner whatsoever with respect to the AABLA. Any such action by the Entrant shall make the Entrant eligible for immediate disqualification from AABLA.

f. Assessment by Judging Panel

i. The Judging Panel shall assess the Entrant based on the Research Information provided by the Research Panel and the Required Information and Supporting Documentation provided by the Entrant.

ii. The Judging Panel shall shortlist from the Entries- Nominees for all 13 (thirteen) Categories of the AABLA Finalists for the Finale Event and the Winners of the Finale Event of AABLA , based on objective criteria and in an impartial manner.

iii. The Entrant shall not contact the Judging Panel in his/her individual capacity or through their entity or otherwise, in any manner whatsoever with respect to the AABLA. Any such action by the Entrant shall make the Entrant eligible for immediate disqualification from AABLA.

g. Entrant's Consent to Research & Judging Process

i. The decision of the Judging Panel is final and binding on all Entrants and the Entrant hereby provides his/her consent to the same.
